## NOTICE TO INDUSTRY

**Subject:** Pilotage Act & its Associated Regulations – Violations & Enforcement

Geographic Area: Compulsory Pilotage Waters of British Columbia including the Fraser River

**Communication:** The review of the *Pilotage Act* is part of the Government of Canada's *Oceans Protection Plan*, a

national strategy to create a world-leading marine safety system. The review of the *Pilotage Act* has been completed and amendments to the *Pilotage Act* received Royal Assent on June 21, 2019. The implementation phases of the legislative and regulatory framework are completed, i.e., the

General Pilotage Regulations are now in effect.

**Application:** Part 2, Division 4, Section 25.9 of the *General Pilotage Regulations* states that every ship over

350 gross tonnage that is not a pleasure craft and every pleasure craft over 500 gross tonnage is subject to compulsory pilotage. If a ship is part of an arrangement of ships, then the combined tonnage of all the ships in the arrangement of ships is taken into consideration in determining

whether the ship is subject to compulsory pilotage.

## **Details:**

PPA wishes to draw your attention to the following:

- 1. The <u>enforcement</u> responsibilities with regard to contraventions to the *Pilotage Act* and *General Pilotage Regulations* now rest with the Minister of Transport, who has powers related to oversight and compliance, including the ability to issue interim orders and ministerial directions. - 2. For ships that are subject to compulsory pilotage, non-compliance with any section of the *Pilotage Act* and its associated regulations, may be deemed as a punishable offence.
